## PROGRAM PURPOSE

1 Fox 2 Productions has a concept. Since 2012 we have designed and implemented two State Approved innovative Drug and Alcohol Education programs. These programs have ultimately resulted in thousands of reinstated driver's licenses in three surrounding cities, Houston, Dallas, and Round Rock, serving these communities and individuals and resulted in thousands of reinstated licenses through completion certificates for 15, hr. drug offender and 12 DWI and online defensive driving classes.

Our accreditation is identified by the City of Austin, Travis County Justice system, Department of public safety and the Department of Child and protective services among others.

Additionally, programs like ours helps remove employment barriers and strengthen local families and communities.

## BAC CHART TO KNOW YOUR LIMIT

0.00 – 0.03% Normal behavior, no impairment

0.03 – 0.06% Mild euphoria and impairment; decreased inhibitions

0.06 – 0.10% Buzzed, euphoric, increased impairment

0.10 – 0.20% Drunk, emotional swings, slurred speech, nausea, loss of reaction time and motor control

0.20 – 0.30% Confused, nauseated, poor mentation, blackout

0.30 – 0.40% Possibly unconscious, unarousable, loss of bladder function, risk of death

Above 0.40% Unconscious, coma, impaired breathing, risk of death

## HELP END DRUNK DRIVING

City records indicate that DWI arrest increased by nearly 24% over the past three years. As well according to research done by MADD, 75% of people with suspended licenses from drunk driving offenses still continued to drive. These numbers can be greatly improved by implementing proper forms of preventive education, INTERLOCK monitoring systems required for occupational DL for drinking offenses, reducing the number of lives saved from repeat or even first time offenders.

## OUR PROGRAMS

**Prevents** drivers from continuing to drive while suspended.

Reduces the number of fatalities caused by drunk driving

**Supports** DPS monitoring services, by referring them to SR -22 insurance and a restricted license – vehicle liability insurance documents – which is required by the Department of Motor Vehicles for those associated with high risk

**Refers** participants accused of a DWI or DUI to a restricted licensed, regulated by DPS, which involves using a monitoring interlock device that requires a clear breathalyzer test to start the car

**Decreases** the high cost associated with accidents

**Combats** barriers for individuals who are unable to acquire a job because of an invalid license
